- Landlords pay \$200 per week for 6 rental passes before 6/15/10
- Checks will no longer be accepted from Renters – all checks must be drawn on the Great Harbors property owner's account
- Landlords who pay after 6/15/10 will be charged \$250
- Renters can pick up cards at the Toll House for each family member (up to six) at the time of occupancy. Each additional card issued (in excess of six) will cost \$25
