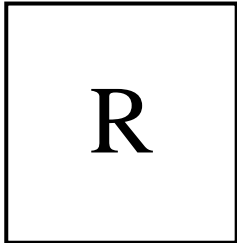

**Summer Renters:**

- \* Renters must present pool and tennis passes only for the house they are renting to gain access.
- \* Renters may not use the homeowner's pool and tennis passes.
- \* Pool season runs June 28, 2020 through September 7, 2020.
- \* Checks must be drawn on the Great Harbors property owner's account. Checks from renters will not be accepted. Cash is accepted.
- \* Renters may pick up cards at the Toll House for each family member at the time of occupancy.
- \* Cards must be presented at the Toll House to use Great Harbors pool and tennis courts.
